UPDATE ON BUILDING STEP CODE IN NELSON

Step Code is a building code process by which the energy efficiency of new buildings is designed and evaluated by qualified experts. By reducing energy use in buildings, we lower the demand on existing infrastructure and more importantly lessen the impacts on our environment. Additionally, the cost to heat and operate homes and buildings is reduced and the comfort is increased for owners and occupants.



Following a presentation to Nelson Council by staff on September 8, 2020, Council agreed to consider increasing Energy Step Code for housing and to introduce Step Code for larger complex buildings. This will increase the minimum requirement on housing to Step level 3 and require a minimum of Step 2 for larger buildings. At this time the proposed adoption date for these changes is January 1st 2021.

In addition to recommending changes to Step Code minimums, staff also committed to review how carbon is accounted for when manufacturing materials for new homes and what carbon is produced during the construction of new buildings. This is referred to as embodied carbon and is an important consideration when we look at the overall effect of buildings on the environment and climate change - in addition to energy efficiency. There will be more discussion on this, in the soon to be released City of Nelson Climate Change Action Plan.
