## NOTICE OF NOMINATION

Public Notice is given to the electors of the City of Nelson and School District No. 8, Electoral Area 1 that nominations for the offices of:

**One Position for MAYOR**

**Six Positions for COUNCILLOR**

**Two Positions for SCHOOL TRUSTEE**

will be received by the Chief Election Officer or a designated person, as follows:

**Originals of emailed nomination documents must be received by the Chief Election Officer no later than 4:00 pm on Friday September 16th, 2022**

Candidates must be nominated in writing by two duly qualified electors of the City of Nelson or for School Trustee of Electoral Area 1 of School District No. 8. The nominations documents shall be subscribed to by the Candidate. At the time of filing the nomination documents, the Candidate shall also file with the Chief Election Officer a written disclosure as required under the Financial Disclosure Act.

**2nd Floor, 310 Ward Street, Nelson BC during regular office hours (8:30 am to 4:30 pm Monday to Friday excluding statutory holidays until the close of the nomination period: 4:00 pm on Friday September 9th, 2022**

## QUALIFICATIONS FOR LOCAL GOVERNMENT OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 15th, 2022;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified under the *Local Government Act* or any other enactment from being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

## QUALIFICATIONS FOR SCHOOL TRUSTEE

A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 15th, 2022;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified under the *School Act* or any other enactment from being nominated for, being elected to or holding office as a trustee, or be otherwise disqualified by law.

## CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2022 general local election, the following expense limits for candidates during the campaign period apply:

**Mayor \$12,671.64**

**Councillor \$6,335.82**
