

RELEASE OF LIABILITY AGREEMENT

**BY SIGNING THIS DOCUMENT YOU WILL WAIVE ALL LEGAL RIGHTS,
INCLUDING THE RIGHT TO SUE.**

To: **City of Nelson and Nelson & District Youth Centre**

Re: Nelson & District Youth Centre located at 608 Lake Street, Nelson, BC

I am aware that skateboarding, cycling and roller-skating/blading involve many inherent risks, dangers and hazards, including but not limited to, impact or collision with skaters, cyclists and spectators; injury resulting from ramp edges, coping or possible flaws in the ramps; being hit or otherwise injured by other skaters' and cyclists' loose skateboards, cycles or equipment; the failure to skateboard safely or within one's own ability or within designated areas; negligence of other skateboarders, cyclists or roller-skaters/bladers; negligence on the part of the Nelson & District Youth Centre or its staff; and I freely accept and fully assume all such risk, dangers and hazards and the possibility of personal injury, death, property damage or loss, resulting therefrom.

In consideration of the **City of Nelson and the Nelson & District Youth Centre** accepting my application to use its facility and permitting the use of its ramps, curbs, spectator area, free/street style area and other facilities (hereinafter referred to as "the Youth Centre facilities"), I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I may have against the City of Nelson and the Nelson & District Youth Centre, its directors, officers, employees, agents and representatives, (all of whom are herinafter collectively referred to as "the Releasees");
2. **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my use of the Youth Centre facilities, due to any cause whatsoever, **INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES**;
3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any property damage or personal injury to any third party, resulting from the use of the Youth Centre facilities; and
4. That this Release of Liability shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.

I have read and understood this **Release of Liability** prior to signing it. I understand its contents and I am aware that by signing this **Release of Liability** I am *waiving all legal rights which I or my heirs, next of kin, executors, administrators and assigns may have against the Releasees.*
